STUDY PERMIT APPLICATION

All persons wishing to study in Canada for 6 months or more must apply for a Study Permit.

Please find enclosed a sheet entitled "Studying in Canada", Study Permit application form, required documents checklist, and payment of the processing fee instructions.

All applications should be submitted at least two months before your intended departure to allow for processing. **Incomplete applications will be refused. Applications that do not include payment will be returned unprocessed.** Please ensure all documents are submitted.

You will be required to undergo a **medical examination** as part of the process of obtaining a Study Permit. More information will be provided when you submit your application.

Applications must be submitted through one of the following designated service providers: **ARAMEX, UPS, TNT and Fifa for General Service**. Passports/documents will be returned by designated service provider **ONLY**.

Processing will usually take **6 weeks** from receipt of a complete application. To avoid disappointment, you should apply at least two months before your intended departure date. In this regard, you should be aware that some educational institutions require foreign students to arrive in Canada at least one week before the start of classes. Applicants will be notified by phone once assessment of their applications is complete.

If you will be accompanied by a dependent(s), and he/she requires a Temporary Resident Visa his/her original passport(s) and the appropriate visa processing fee must be included, as per the included fee payment instructions.

Passports/documents will be returned by designated service provider **only**.

All applicants must be prepared to attend a personal interview if required.

We do not process applications received by fax.

Visa Processing Fees

Visa Processing fees are **non-refundable** regardless of the outcome of the application.

Method of Payment

Processing fees MUST be paid by **"BANK DRAFT"** (only) in CANADIAN DOLLARS. Bank Drafts must be drawn on Canadian bank showing the full mailing address of the bank in Canada. Bank drafts must be valid for 6 months and must be made payable to **"THE RECEIVER GENERAL FOR CANADA"**.

IMPORTANT NOTICE:

WE DO NOT ACCEPT bank drafts in Saudi Riyal.

WE DO NOT ACCEPT payment by personal cheque, company cheque, drafts drawn on foreign banks, Canadian dollar drafts drawn on banks outside Canada, Canadian postal orders or Canadian cash.

STUDYING IN CANADA

I want to study in Canada. What should I do?

We thank you for your interest in studying in Canada. Canada has a long and successful history of educating international students. Because your decision to study in Canada is important, we have prepared this hand-out to explain the necessary requirements.

The first requirement is to be accepted by a certified institution in Canada. The names and addresses of various universities and educational institutions in Canada can be obtained through the Public Affairs Section of any Canadian Embassy or Consulate. You can obtain more information please check the Web site: <http://www.studyincanada.com> After receiving an acceptance letter from an educational institution, you should apply for a study permit or a temporary resident visa, depending on the type of course and its duration. Applicants residing in Saudi Arabia apply at the Visa Section of the Canadian Embassy, Riyadh, Saudi Arabia.

What is a Study Permit?

A study permit is a document that enables its holder to stay and study in Canada for the authorized period. In addition, students will be issued a temporary resident visa to be able to travel to Canada.

I'm going to take a language course in Canada. What am I going to need?

- * If you intend only to take a language course for a period of less than 6 months, you do not need a study permit but a Temporary Resident (TR) Visa (formerly Visit Visa)
- * If you are accepted for a language course for a period of 6 months or less, but intend to take another course as soon as the first one is finished, you will need a study permit (accompanied by a TR visa, if necessary) so that you can later obtain in Canada an extension of your study permit for the second course.
- * If the duration of the course is more than 6 months, you will require a Study Permit accompanied by a TR Visa.

Important: Please note that a person admitted to Canada as a tourist cannot change his/her status to that of a student or obtain a study permit from within Canada.

I'm going to study in the Province of Quebec. Is there anything more that I need to obtain?

If you intend to study in the Province of Quebec, you must also obtain a "Certificat d' Acceptation du Quebec" (CAQ) directly from the Immigration authorities of that province. The information on how to proceed will be sent directly from the educational institution of that province. If you intend to take a language course in a Quebec educational institution other than at a primary or secondary school, or at a university, then you do not need a CAQ.

Who needs to undergo the medical examination?

- * Persons who intend to stay in Canada for 6 months or more must undergo a medical examination before departure.
- * Medical professionals who will study or work in the field in Canada, must undergo and pass a medical examination, regardless of the period of intended stay in Canada.

What do I have to do to undergo a medical examination?

On receipt of your application for a study permit, payment of the processing fees and all the required supporting documentation, medical forms will be issued with the list of Designated Medical Practitioners.

What is the processing time to obtain a Study Permit?

Normally you will obtain your study permit within six weeks of receipt of your application if you have provided all the requested supporting documents, and if no CAQ is required. We advise that student applicants who require a CAQ to initiate the process for obtaining a study permit as soon as possible.

What do I need in terms of Financial Resources?

You must satisfy the Visa Officer that you have sufficient financial resources to pay your tuition fees, transportation costs to and from Canada, as well as living expenses for yourself and any dependant(s) who may be accompanying you, without the need to engage in employment.

The following is a general guide to help you estimate your living expenses:

- Student-\$10,000 for a twelve-month period, plus the cost of tuition.
- Accompanying Spouse-\$4,000-6,000 for a twelve-month period for spouse.
- Accompanying Dependants-\$3,000-\$4000 for a twelve-month period per dependent child of any age.

Or what if my parents will be covering my expenses?

If you are still a dependant of your parents, and they will be covering your expenses while you are in Canada, their financial documents must be presented. In this case, even if you are no longer considered a minor, you must also present a declaration of financial responsibility from a parent or guardian, authorizing you to go to Canada and taking financial responsibility for your expenses during your entire stay in Canada.

Can I work while studying in Canada?

Full-time students registered in degree or diploma-granting courses are allowed to work on the campus of the institution at which they are registered. Work Permits are not required. Spouses of full-time students are also eligible to work in Canada provided they are not themselves studying in Canada. A spouse of a holder of a study permit, who is attending full-time a post-secondary institution, which is also publicly-funded degree or diploma-granting institution can apply for a work permit in Canada.

Important points to remember about your Study Permit and Temporary Resident (TR) Visa.

* You must make sure that your study permit continues to be valid. If you are accepted for a new period of studies, it can be extended at the Canada Processing Centre in Vegreville (CPC), Alberta, Canada.

*** The extension of a study Permit in Canada does not extend the TR visa. The study permit is a document that authorizes you to stay temporarily in Canada to study, while the TR Visa is a document that allows you to travel to Canada. If your TR Visa has expired and you travel outside Canada and the United States, you will need a new TR Visa to return to Canada. The TR Visa cannot be renewed from inside Canada. To obtain a new visa, it is necessary to apply at a Canadian Consulate or Embassy outside Canada.**

*** Applying for a study permit and TR Visa is simple and straight forward but requires timely and complete compliance with the above requirements by the applicant.**

REMEMBER, it is your responsibility to ensure that your application is properly completed, that all required documents are included with your application, and that you follow all instructions from the Canadian Embassy in Riyadh concerning the processing of your application.

* All correspondence will be forwarded by regular mail unless you clearly instruct the Embassy in Riyadh that you wish to use a specific courier (DHL, FedEx, Aramax, etc). You must agree to accept to pay the fee upon delivery or simply provide your courier account number .

There are many courses available in Canada. Unfortunately, Citizenship and Immigration Canada including the visa section at Canadian Embassies cannot provide information on any specific courses of study. However, you can obtain information at the following internet sites:

Student Permit Application Checklist

Assemble **COPIES** of all your documents as listed below. Check each applicable item on the checklist and attach the checklist to your application form.

COMPLETED AND SIGNED APPLICATION FORM (IMM1294)

- You **must staple** 3 recent passport-sized photos of each person included in the application, with name and date of birth written on the back. Men must not wear any head covering.
- Please ensure you include a **telephone, fax number and email** on the application so we can contact you if necessary.
- You, your spouse, and your children who are less than 18 years old may be included in the same application.
- Separate application needs to be filled for each child over 18 years old.

SUPPLEMENTARY INFORMATION FORM

Complete the supplementary & Travel information forms.

FEE PAYMENT

Please refer to Payment Instructions

- * **FEES ARE NON-REFUNDABLE REGARDLESS OF THE OUTCOME OF THE APPLICATION.**

VALID PASSPORT OR TRAVEL DOCUMENTS

You must include your and your accompanying dependants original passport or travel document and copy of the photo page with the application. You should renew your passport before you apply if required so that a permit can be issued for your entire period of studies in Canada. This will prevent you having to pay to have your permit renewed in Canada.

- * **PLEASE NOTE THAT A PERMIT CANNOT EXTEND BEYOND THE VALIDITY OF YOUR PASSPORT.**

ACCEPTANCE LETTER

Copy of a valid acceptance letter from the Educational institution in which you are intending to enrol in Canada. The letter should clearly state the program title and the commencement or deadline date for registration as well as the expected completion date of studies.

SCHOOL/COLLEGE TRANSCRIPTS

Copy of your complete transcripts from all of your previous studies, including high school, university, language courses and any technical training. These should be in English or in French .

PROOF OF FUNDS

Documentary proof of sufficient funds (e.g. bank statements for last 6 months, etc.) to cover the cost for the entire period of your education and related expenses in Canada.

DECLARATION LETTER OF FINANCIAL SUPPORT

If you are being funded by another person or organization, provide an original letter from them stating that they will fully support you financially during your studies in Canada.

Private supporters (parents/relatives) must provide their own proof of funds as per #7 above.

EMPLOYMENT LETTER

A letter from your or your private financial supporter's employer stating position, salary, length of service and dates of contract. If self-employed, a copy of the business/trade licence is required.

CUSTODIAL DECLARATIONS FOR STUDENTS UNDER 18

You must supply a notarized declaration, one signed by your parents and one by the custodian in Canada stating that arrangements have been made for the custodian in Canada to act in place of a parent.

CAQ "Certificat d' Acceptation du Quebec"

If you intend to study in the Province of Quebec, you must also obtain a (CAQ) directly from the Immigration authorities of that province. The information on how to proceed will be sent directly from the educational institution of that province. You must submit your (CAQ) to this office as soon as possible.

NOTES

- * Submit only copies of original documents. You may be asked to submit originals at a later date.
- * Please ensure that your application is complete and that all required documents are provided. Incomplete applications will be refused.
- * The embassy reserves the right to request a personal interview or any other document it deems necessary. Moreover, the submission of an application with all the required documents does not ensure that a visa will be issued. Visa issuance is at the total discretion of the embassy.


Requirements:

You must provide 2 photos with your application for a Temporary Resident Visa, Study Permit, or Work Permit. It is imperative that your photos be compliant with the following specifications otherwise they will be rejected. You will be required to provide new photos before your application can be processed.

To avoid delays, please ensure that the photos provided with your application meet these requirements.

Photograph specifications:

- Two identical photos, black and white or colour, taken within the last 6 months.
- Must be clear and well defined, taken against a plain white or light coloured background.
- Digital photos must not be altered in any way.
- The face must be square to the camera with a neutral expression, neither frowning nor smiling, with the mouth closed.
- Tinted prescription glasses may be worn as long as the eyes are clearly visible and the frame is not covering any part of the eyes. Sunglasses are not acceptable.
- False hairpieces or other cosmetic devices are acceptable if they do not disguise the natural appearance of the bearer.
- Photos in which the applicant is wearing a hat or head covering worn for religious reasons are acceptable if the full facial features are not obscured.
